

## LICENCE

Unless you, the Licensor, expressly state otherwise (for example, in relation to commercially confidential information), you will be taken to have agreed, in exchange for due consideration of the Licensed Materials and the payment of 1 (one) peppercorn (if demanded) by the Government of the Hong Kong Special Administrative Region ("the Government"), to

- (1) grant to the Government and each person and, as the case may be, each other person, sitting from time to time on the Committee on Review of Post-service Outside Work for Directorate Civil Servants ("the Committee") an irrevocable, perpetual (to the extent permissible by law), non-exclusive, worldwide, freely transferable, sub-licensable and royalty-free licence ("this Licence")
  - (a) to use the Licensed Materials in any manner including without limitation the rights to possess, store, display, exhibit and publish the Licensed Materials in any medium (whether now known or invented in the future);
  - (b) to reproduce in any medium (whether now known or invented in the future) copies of the Licensed Materials and to distribute or issue the copies so made to the public or otherwise; and
  - (c) to adapt and/or edit the Licensed Materials;

PROVIDED that in each case at (1)(a) – (c) above the Government and/or the Chairperson of the Committee (or the Deputy or Acting Chairperson as the case may be) from time to time authorises the said use, reproduction, distribution, adaptation and/or editing for or in connection with the terms of reference of the Committee including any comment, finding, report, recommendation, submission, presentation or response made or to be made for the purpose or in consequence of the said Review or the work of the Committee;

- (2) warrant in favour of the Government and each person and, as the case may be, each other person, sitting from time to time on the Committee that :
  - (a) you have been either the sole/co-owner of the intellectual property rights in the Licensed Materials since the creation of the Licensed Materials or have acquired a sub-licensable licence from the owner of the intellectual property rights in the Licensed Materials;
  - (b) you have full power to grant this Licence and to give the warranties and indemnities contained in this Licence;

- (c) the Licensed Materials are created solely/jointly by you and another person/other persons who is/are bound by a licence on terms similar to this Licence; and
  - (d) the exploitation, use and/or possession of the Licensed Materials (prior to, on or after the granting of this Licence) by those persons (including the Government) to whom this warranty is given has not infringed and will not infringe the intellectual property rights or any other rights of any third party;
- (3) agree to indemnify and keep the Government and each person and, as the case may be, each other person, sitting from time to time on the Committee fully indemnified against all losses, damages, demands, actions, claims, proceedings, costs and expenses (including any damages or compensation paid by the Government and/or any person(s) sitting on the Committee on the advice of its, his or their legal advisors to compromise or settle any claim) arising out of or in relation to any breach of any of the above warranties or any allegation which if substantiated would constitute such a breach;
  - (4) irrevocably and unconditionally waive all your moral rights (including the right to be identified as the author and the right to object to derogatory treatment of your work) in respect of the Licensed Materials to which you may now or at any time in the future be entitled under the Copyright Ordinance (Cap. 528) and under any similar laws in force from time to time in Hong Kong; and
  - (5) agree to do all things and execute all such documents without cavil or delay as may be necessary to give full effect to this Licence.

For the purposes of this Licence, "Licensed Materials" mean any compilation of views and information that you provide in written including electronic submissions to the Government and/or each person and/or, as the case may be, each other person, sitting from time to time on the Committee.

In the event of any inconsistency or ambiguity between the English version and the Chinese version of this Licence, the English version shall prevail.

**Note :**

Pursuant to section 182 of the Copyright Ordinance, Cap. 528, the Government is the first owner of copyright in the works produced by officers of the Government such as the Secretariat to the Committee in the course of their duties.

By this Licence (and subject to its terms) the Government and each person sitting from time to time on the Committee have the benefit of a similar licence to use, reproduce and adapt etc. the Licensed Materials for the purposes of the said Review.
