Dear Hon. Arculli,

Consultation on Review of Post-Service Outside Work for Directorate Civil Servants

Thank you for your letter dated 20 February 2009.

On behalf of the Hong Kong Retired Civil Servants Association, I set out below our views and comments on the above subject.

We suppose that the reference to Directorate Civil Servants would include those on contract basis as well as those on pensionable establishment. In this connection should not the need to maintain one's living after leaving the civil services for those not in receipt of monthly pension be also taken into account in formulation a policy for granting post-service outside work?

In broad terms, we consider it unfair to impose a life-time ban or prolong period of restriction for the ex-Directorate Civil Servants to take up paid employment unless such paid employment is perceived as a "deferred reward" for past favour done during government service. Each case must be considered on its individual merits.

The matter should not be dealt with by a "blanket policy" in fixing sanitation period etc. In some particular cases "Nil" sanitation period may be more appropriate. For example, a medical consultant in possession of special expertise may be required to take up surgical operation on a private patient shortly after leaving civil service. In this instance, the imposition of a sanitation period will deny the private patient the access
